## ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

### SUMMARY

#### **Offer Price and net proceeds from the Share Offer**

The Offer Price has been determined at HK\$0.22 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Based on the Offer Price of HK\$0.22 per Offer Share and 250,000,000 Shares offered by the Company, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and commission, and other estimated expenses in connection with the Share Offer payable by the Company, are estimated to be approximately HK\$32.2 million. The Company intends to use the entire net proceeds from the Share Offer in the manner set out in the paragraph headed “Offer Price and net proceeds from the Share Offer” below in this announcement and the section headed “Future Plans and Use of Proceeds” in the Prospectus.

#### **Applications under the Public Offer**

The Public Offer Shares initially offered under the Public Offer have been well oversubscribed.

A total of 19,345 valid applications pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving electronic application instructions to HKSCC via CCASS for a total of 8,372,890,000 Public Offer Shares were received, representing approximately 334.9 times of the total number of 25,000,000 Public Offer Shares initially available for subscription under the Public Offer.

As the number of Public Offer Shares validly applied for in the Public Offer is more than 100 times, the reallocation mechanism as described in the section headed “Structure and conditions of the Share Offer — Reallocation” in the Prospectus has been applied. The final number of Offer Shares allocated to the Public Offer is 125,000,000 Offer Shares, representing 50% of the total number of Offer Shares under the Share Offer. There are a total of 11,240 allottees.

#### **The Placing**

The Offer Shares initially offered under the Placing have been moderately oversubscribed, which is equivalent to approximately 1.9 times of the total number of 225,000,000 Offer Shares initially available under the Placing. After the reallocation, the final number of Offer Shares allocated to the places under the Placing is 125,000,000 Shares, representing 50% of the total number of the Offer Shares under the Share Offer. There are a total of 303 places. A total of 181 places have been allotted five board lots of Placing Shares or less, representing approximately 59.7% of the total number of places under the Placing. A total of 4,300,000 Placing Shares have been allotted to these places, representing approximately 3.44% of the Placing Shares.

The Offer Size Adjustment Option has not been exercised by the Sole Bookrunner and has accordingly lapsed.
